

## **Nancy Goodman Biography**

In 2010, Kids v Cancer launched a post mortem pediatric brain tumor tissue donation program to help families with children with terminal brain cancers donate their children's brain tumor tissue to science.

In 2012, Kids v Cancer's Creating Hope Act Pediatric Priority Review Voucher Program, which creates a market-based incentive to spur pediatric rare disease drug development, was passed into law as 21 USC 360ff. Since then, \$1 billion in vouchers have traded with the last voucher trading at \$350 million, providing a significant incentive for pediatric rare disease drug development.

In 2016, Kids v Cancer launched a Compassionate Use Navigator to facilitate physician and family compassionate use applications to investigational drugs.

In 2016, Congress introduced a bill championed by Kids v Cancer, the RACE for Children Act (HR 5858, S 3239) to reform the Pediatric Research Equity Act. In July, 2016, *Nature* endorsed the RACE for Children Act in an editorial.

In 2016 Kids v Cancer is asking Congress to permanently reauthorize the Creating Hope Act Pediatric Priority Review Voucher program.
